Note while this information is unaudited and small changes are expected in compiling the annual financial statements to be presented at the AGM, the board feel it's a reasonable approximation of our financial performance

Commentary

- While grants and program revenues are down compared to the prior year they were ahead of budget as
 ASNL was able to obtained 4 grants that were not budgeted. The grants are down compared to the prior
 year as our grant from the provincial government was reduced.
- Fundraising revenue increased primarily as a result of the success of the Spring Gala and a steady stream generous donations made to our society
- The Pantry's financial performance deteriorated over the fiscal year and the board is working with management to improve it this year
- Expenditures were in excess of budget mainly resulting from increased employment tied directly to grants which were received but not budgeted for.
- The overall financial health of the organization is solid allowing the society to deliver on its mandate
